Eligibility: This award shall be bestowed on a nominee in actual service during the year but may be based on either accomplishment during the year or cumulative years of activity. Both nominator(s) and nominee must be current members of the Florida Library Association.

The overall accomplishments of the nominee should have aided in developing and strengthening the image of the library as a public service agency.
