Nominee can be a single library or part of a library system or consortium. The program must have been conducted within the previous calendar year. Both nominator(s) and nominee must be current members of the Florida Library Association.

Criteria:

Nominees will be recognized for noteworthy service for a program that supports one or more aspects of workforce development, small business support, community development, and employment.
